- NO SKATEBOARDS, ROLLER BLADES, BICYCLES OR MOTORIZED RECREATIONAL VEHICLES.
- NO INFLATABLES
- NO SOLICITING OR SALES ACTIVITY OF ANY KIND
- NO PARTISAN POLITICAL ACTIVITY, FUNDRAISING OR CAMPAIGN ACTIVITY OF ANY KIND.
- NO LITTERING. TRASH MUST BE PLACED IN CONTAINERS.
- NO FIRE WORKS, ROCKETS CANNONS, FIRE ARMS OR EXPLOSIVE DEVICES OF ANY TYPE OR THROWING PROJECTILE.
- LIVE MUSIC/ENTERTAINMENT MUST BE APPROVED BY THE BOARD OF TRUSTEES.
- RESERVED SHELTER HOURS ARE 12 TO 4 OR 5 TO 9 (4 HR LIMIT)
- PARK CLOSES AT DARK UNLESS OTHERWISE AUTHORIZED BY THE BOARD OF TRUSTEES.
- \$25.00 NON-REFUNDABLE FEE PER SHELTER/FOUR HOUR PERIOD
- **SHELTERS MAY BE RESERVED ONLY BY PORTER TOWNSHIP RESIDENTS BY PAYING AT THE TOWNSHIP HALL LOCATED AT 1535 DOGWOOD RIDGE ROAD – 740-574-4245**
- THE PORTER TOWNSHIP TRUSTEES MAY WAIVE THE FEE FOR USE OF ONE SHELTER, FOR ONE FOUR HOUR BLOCK OF TIME PER DAY, BY NON-PROFIT CIVIC ORGANIZATIONS, CLUBS, CHURCHES AND SCHOOLS, WHO HAVE FACILITIES GEOGRAPHICALLY LOCATED WITHIN PORTER TOWNSHIP.
- THE GAZEBO **CANNOT** BE RESERVED; IT IS TO BE LEFT OPEN FOR THE PUBLIC.
- FIRST COME, FIRST RESERVE, NO RESERVATIONS TAKEN BEFORE JANUARY 2 EACH YEAR.
